At HPBExpo25, exhibitors can **Burn More, Sell More**, with our updated burning regulations that allow more live burns!

Burn requests must be reviewed and approved by HPBA Show Management and the convention center. Early submission of request is strongly recommended.

Requests submitted after the December 31 deadline risk not being approved.

# **Exhibit Insurance Requirements**

All exhibitors must carry general liability coverage with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate.

We have once again partnered with Rainprotection Insurance to provide an affordable option for temporary exhibitor insurance.

**Indoor Burning Request Form** 

Submit requests to burn for approval in advance of placing gas order.

Deadline: December 31, 2024 (submit early if possible)

**Outdoor Burning Request Form** 

Fuel requests submitted after deadline may not be

honored.

Deadline: December 31, 2024 (submit early if possible)

**Meeting Request Form** 

All events occurring the week of HPBExpo must go

through an approval process. **Deadline: January 24, 2025** 

**Exhibitor Appointed Contractor - EAC Request Form** 

All EACs must be approved in advance of set-up.

Deadline: February 24, 2025

Variance/Hanging Sign/F&B Approval Form

All overhead hanging signs and food/beverage serving

must be approved in advance. **Deadline: February 24, 2025**

#### WHAT OFFERS ARE LEGIT?

You may receive other third-party offers for everything from hotels to booth carpet. While some offers may not be "bogus", they can **end up costing you extra** in added move-in fees for using an **unapproved vendor**.

**Approved vendors** for HPBExpo will have ordering information posted on our **online Exhibitor Services page**.

# Don't be Fooled by Fakes

Be aware that scammers are working hard to find victims for their fake lists, false hotel reservations, faux exhibitor listings, and fraudulent payment information.

Chances are, you will receive emails or calls from companies or individuals soliciting these services. And, chances are very good that they are bogus offers.

One of the more popular scams is the Attendee List offer. **HPBExpo does not sell its attendee list,** therefore the lists these so-called vendors are offering are not ours. And sometimes, there is no list at all - it is just a scammer attempting to get your credit card information.

Unfortunately, this is an issue throughout the trade show community. The most important thing we can do is educate YOU - so that you don't fall victim to these offers.

#### Watch for Red Flags such as:

- Email is from a first name only and address contains an unknown domain name
- Email is from someone you don't recognize
- Email does not contain company information below sender's closure (no "signature block")

If you are in doubt of an offer you have received, first ask HPBA Show Management staff. We can verify or deny the validity of the offer for you and send a cease-and-desist letter to the sender. Unfortunately, these individuals tend to reinvent themselves over and over by creating a new "name" and email address with a new offer. It's best to move these emails to your trash folder. Don't hit "unsubscribe" or reply to the sender; both of those options only confirm to them that your email is valid and will result in MORE fraudulent offers.
